Regional Webmaster Report: Justin:



January area meeting

There were 5/7 GSR's (7 active GSR's in the Area), 4/5 executive committee members, and 1/4 ad hoc chairs.

Treasurer— Will go to bank once a new treasurer is voted in. Our checking account balance is 327.15. Our savings account balance is \$401.31. This year we donated \$856.50 to region, paid \$828 in storage fees, and donated \$777.72 to world.

PR– Jail and Literature both were absent but sent in reports. We are still planning on having learning days on April 24, 2021. New Business:

Open Forum:

Changing Location for the storage unit: Is there any reason to keep the storage unit in Sandy. Tanith states that may be an issue if we move it for the people that are further away. James H states that we should base it on cost rather than location because Campvention only uses it 3 times a year. Brittni has had issues with them communicating, with the contract, and with that they require going in person to make changes. Lets do a little bit of investigating to see if we can find a cheaper storage unit. We do need to double check the size.

NAWS income and contributions: James K – as everyone knows NAWS is based on literature sales. It has been a topic of discussion that started pre pandemic that it is not a sustainable model. The discussion has been happening and now the pandemic has caused more of an

emergency during this discussion. It was discussed today on the web call — what can we do to help members understand what services we provide and what money does to help? A lot of the discussion was around communication and who benefits from the services received. What can we do to help new member understand more about the contributions and what they are for? What are the hurdles that we need to overcome? Lets face this head on with the RCMs to what we can do and hopefully can figure out where we are at in the discussion. There is value to the literature, its not just a book! It helps to provide services like the meeting lists set out by World so that people can find meetings when they need it.

Tanith reports Central uses baby blues and they are bought by the groups. The likelihood of Central making a World donation is low. People learn through their sponsors and sometimes don't see the other side – its not a matter of money, it's matter of principle.

Cody reports Lakeside does a 10% monthly to World and 20% to Region. The experience from homegroup level service has helped to understand why things money goes to World. At the group level we make a donation to World, Region and Area to support the cause. My Sponsor compares what we spent on dope to what we put into the basket is minimal. The program wont last and be here if we don't contribute. More groups have started doing this. Also, at the homegroup level for birthdays you would put the number of years clean in dollars for your clean time to help fund.

Phil asked how realistic the 3.9 million in donations is. How much was donated in 2020? James doesn't have the exact figures. How do we even approach the deficit? James says a realistic goal is \$100 per meeting per year is what has been published.

James H reports its around 800,000 per year in donations. We make donations to the fund flows because we have been taught to do that. There are so many issues with the fund flow structure – our area doesn't have a donation to World because the structure is just old and not updated. The concept of individuals giving back has been around a while but I think we need to show the addicts what happens to the dollars to know where they go and what they are used for. A workshop explaining why literature goes up in price, what services we are paying for etc. It starts with information at the individual level. The fund flow at different regions looks completely different where thousands of dollars are being given back after conventions or even from individual groups. Support what is keeping you clean and alive. Most of the spending done by groups in our area is to literature not into the donations and service structure and fund flow.

Sarah reports in her area there are people with strong opinions on both sides. We keep our money local and provide for local services – it has no come up to talk about if we should donate to World again. I am willing to have the discussion at Area.

Steve advises there is a money matters IP.

James would like to hold a virtual workshop on fund flow and discuss these items. Would also like to do a donation drive and pit the areas against each other. Even if it only raises a couple hundred dollars that would support a couple meetings! I will come prepared next cycle with information. If we can make a model it can be used in different Regions and Zones if it works. We will get a report of the actual numbers NAWS is working with.

Calls and emails to RD and RDA from unsolicited people – do RCM's want our RD and RDA to spend time on these unsolicited emails? James K states the guidelines state that they are to report information back from WSC to the Regions not to go through a bunch of social meeting and extraneous groups of people. General consensus from the RCMS is to just keep doing what they are doing and ignore the emails.
