

# Utah Regional H&I County Jail Literature Distribution Proposal for 2/13/2021

Hello all!

Here is the proposed distribution list for Narcotics Anonymous literature in our 26 county jails. As you can see from the Utah Counties map, our areas are committed to furnishing NA literature in 15 of our 26 county jails. This leaves 11 county jails that we will be shipping NA literature to. Our literature budget is \$2328.78, and I am proposing literature expenses of \$1849.97 including California sales tax. That would leave us with a balance of \$478.81 for shipping to these 11 facilities. Whatever is leftover we will distribute to Point of the Mountain and Gunnison state facilities.

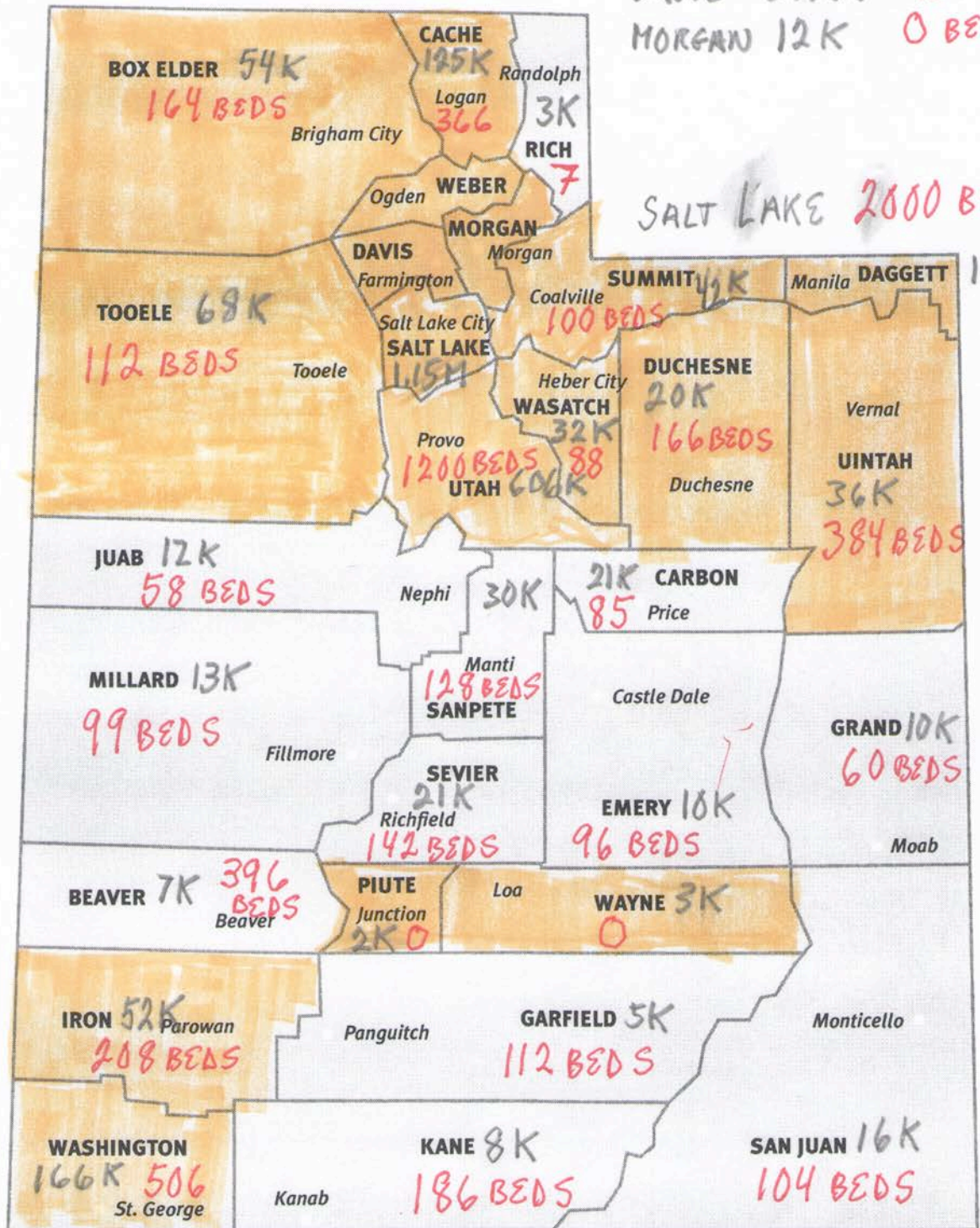
Our proposed basic package per 100 inmates is as follows: 5 Basic Texts, 3 *It Works How and Why*, 3 Step Guides, and 3 *Just for Today*. The total cost for a basic package is \$145.05 plus \$10.52 CA sales tax for a total of \$155.57.

Grand county and Juab count have 60 & 58 beds, so the proposed package is 3,1,1,1 which is a total of \$69.35 including tax. In Beaver and Kane county we are proposing two basic packages.
