- Rocky Mountain Zonal Forum next meeting will be January 2023 to review CAR/CAT for WSC2023.
- Next CP Web call will be on October 22, 2022. Major topics of this meeting will be:
 - Future of the WSC
 - Maybe an update on the Iran Literature lawsuit...

- Important dates and deadlines
 - in-person, if possible, 30 April - 6 May 2023 in Chatsworth, CA
 - RDA travel will be covered the Utah Region as done previously
 - RD travel is moving towards an 'Opt-In' travel cost for RD travel. The Utah Region has the option to request the Conference to cover the cost of the RD travel. In years past this was automatically done.
 - Regional Report is Due February 1, 2023
 - CAR will be out by November 30, 2022
 - CAT will be out by January 30, 2022

- We need to determine when and how the Region would like to have CAR and CAT presentations. It should happen after 1/3/23 if the Region wants the RD team to present on the CAT in addition to the CAR.
 - We will also need to determine how we collect the Regional Conscious. In years past, we have taken one vote per homegroup, and collected votes through a Google Form. We will proceed this direction unless the Areas would like to see a change.



Greeting URSC Family!

I have been getting oriented over the past two months and learning about what is going on with PI initiatives in several Areas. I want to thank everyone for being so welcoming and for the openness to share their Area’s PI experience. Here are a few highlights:

Area Communications - I have reached out to High Uintah, Lakeside, Sasquatch, Southern and UWANA Areas to find out about current PI activities, talk about how things are going and find out what the region could do to provide better support. There is a lot of enthusiasm across the board as face-to-face

meetings are starting back up. The primary focus for most is reengaging H&I activity and there is quite a bit of overlap between H&I and PI in many areas. One area of common interest would be for the development of a comprehensive list of professionals in Utah and to start regular communications with them. More will be revealed in this regard.

Public Communications - There have been no requests for information in the past 60 days.

Committee Meetings - There is interest in restarting the PI Subcommittee and task force activity to support speaker lists, information packets, contact lists of professionals, material for posters and a library of presentation material. I would like to discuss this with the RSC when appropriate in the meeting today. I was thinking about scheduling a virtual PI Committee meeting on the second Saturday of ODD months starting in January or March but wanted to ask for your thoughts and suggestions.

WSO Communications - There is a worldwide PI/PR Workshop that will be held on Saturday, November 5th from 11 – 12:30 PM. Topics will include starting a PI/PR committee, collaboration with H&I, Activity outside the US, and the gratitude and joy other PI enthusiasts have found in service work. A flyer for this event is included in this report. Please share this with PI enthusiasts in your Area?

- Everything is on track for the URICNA 23: Just For Today. No blockers, no emergencies. We do have one item to put to RCMs:
- Members sometimes ask for jewelry. Our guidelines are unclear/ambiguous about alternative, for-profit merch (versus alt merch from other conventions, areas, etc). But we do use a tape guy who is a for-profit vendor. His contract is 30% of net income goes to the convention, among other stipulations. We were thinking of using a similar contract if we were to have a jewelry table on Sunday. This came up because a licensed NA-jewelry vendor contacted us. Since the guidelines are ambiguous, we'd like the RCMs to vote on whether or not to allow this, and to approve the gist of this contract, which is attached. Friendly amendments to the contract are welcomed obv. – **THIS WAS BROUGHT TO THE REGIONAL COMMITTEE WITH NO OBJECTIONS AND THIS WILL BE SOMETHING THAT WILL BENEFIT THE FELLOWSHIP AND THE COMMITTEE.**

Agreement for external/for-provide merch vendors

For-profit, licensed NA merchandise vendors may be allowed to sell merchandise at the convention under the following terms.

1. Vendor may not promote or sell merchandise at any time or location other than their designated area during the designated Alt Merch hours.
2. Vendor will remit 30% of operating income to Convention Committee Treasurer or Program Chair at the conclusion of the Event. Operating Income is Sale Price minus direct product cost.
3. Vendors may set their own pricing but may not make special discounts available that are not available to every member in attendance equally.
4. Vendor must accept credit cards and cash and must provide their own starting bank for change.
5. Convention Committee agrees to provide the vendor with one table according to the hotel's BEO.
6. Vendor may not use the Convention name or artwork to promote merchandise on their signage.
7. Convention Committee agrees to make the Alt Merch hours available to the vendor 14 days before the event.
8. Vendor may not display signage anywhere but on the table and may not put signage or posters on the hotel walls.
9. Vendors may take advantage of the room block discount as long as rooms are available, but the committee makes no concession for guest rooms or other expenses.

Track A is themed: "Any addict can stop using, lose the desire to use..." and Track B is themed "...and find a new way to live." All topics come directly from NA approved literature.

- We will meet at Noon on Friday 11/11 at the hotel to setup if anyone wants to help.

Here is a message to all RCMs about the hospitality room—this message has already gone out by email, separately, this is just for the minutes.

"Thanks to the NA Areas for agreeing to sponsor a small stock-up of the hospitality room for URICNA 23, Nov 11-13. We have a nice room for hospitality this year, and a great host hotel.

What: Areas have agreed to stock up on small, pre-package snacks and drinks for fellowshiping and hanging out, but not for full meals! Nothing homemade, only pre-packaged snacks and fruit with a

natural “wrapper” they said. Coffee and water provided by the hotel, elsewhere in the facility, so don’t worry about that.

Examples: juice boxes and mini sodas are popular. Fruit snacks, trail mix, crackers, chips, cookies, jerky, candy, etc. Imagine what you’d put in a 4th grader’s lunch box. The committee will provide napkins, but don’t bring anything that would require silverware. If you’re an early shift, consider breakfasty stuff. Don’t count on refrigeration; we will try to ice the drinks, though. If there is refrigeration we will email RCMs separately.

How much: whatever your area can pull together! There are 6 areas and each one is bringing something. We are counting on 400 members coming through on Saturday. We’re asking you to stock it at the time below, clean up a little, and keep an eye on it until the next stock-up. But it doesn’t need to be staffed. And if it runs out, it’s okay! Please also feel free to trade with another RCM; this is not posted anywhere and the committee trusts the areas to handle it.




Currently have 11 facilities plus the Tooele jail, and men's and women's prisons, still waiting on SL county jail to re-open.

- PR - web, meeting schedules updated, some racks filled, attended recovery day and handed out lots of literature at that booth. Planning to try to get more involvement with H&I people to open more possibilities.
- Activities has had several activities including a comedy show they went to most recently - two events coming up, haunted maze next week, and Halloween dance/speaker meeting on the 29th.
- Outreach visited 4 meetings last month, continuing to support struggling meetings
- UWACNA campout went well, same committee is now planning a New Years Eve event with Lakeside Area
- All meetings going well, 24 total with 2 of which are zoom meetings which are part of in-person homegroups.
- Working on a plan for a thanksgiving dinner (earlier in the day) on the holiday, also created an ad-hoc committee for a "12 days of xmas" where homegroups could have games, dinners, white elephant exchanges, or whatever they come up with on the days leading up to xmas (or around that time) - basically a daily after-meeting event for 12 days straight, idea taken from an area in CA.

Group Conscience for voting on CAR and CAT – in the past it has been done by group – no objection to continuing that way from this body directly – feel free to bring back any suggestions from groups.


