Utah Regional Outreach Report

Event: Celebration of Recovery - Vernal, Utah

Dates: June 6-8, 2025

Summary of Visit:

On my recent visit to the Celebration of Recovery in Vernal, hosted by the High Uintah Area of Narcotics Anonymous, I had the opportunity to participate as a workshop presenter, connect with local members, and assess the areas outreach needs and capacities.

Workshop Highlights:

I led a workshop during the event where I introduced myself, shared personal recovery experiences, and discussed the role and purpose of Outreach at the regional level. I also opened the floor for discussion and questions. The response was warm and engaging. I provided my contact information to multiple members and collected phone numbers for future connection.

Observations and Strengths:

Despite geographic isolation and logistical challenges, the members in High Uintah are doing an impressive job maintaining recovery in their community. The fellowship in this area demonstrates strong unity, dedication, and creativity in overcoming barriers. Meetings are consistent, and there is a clear sense of commitment among those who participate, even when their lives and schedules present significant obstacles.

Identified Challenges:

One of the core challenges in the High Uintah Area is the transient nature of employment. Many members work in oil fields or ranching often requiring them to be away from home for days or even weeks at a time. Some ranchers only come into town once a week for their homegroup meeting. As a result, maintaining service commitments that require consistent attendance can be difficult. Even those willing to serve often find themselves unavailable due to work obligations.

Another challenge is the lack of an RCM (Regional Committee Member) for the area. Without representation at the regional level, the area has had no formal avenue to communicate needs, share concerns, or receive information from Region.

Proposed Solutions and Next Steps:

After discussing this with several members at the event, they agreed to begin compiling a list of members' email addresses who are interested in receiving Utah Region meeting minutes and other relevant updates. I will be the point of contact to receive and share these email addresses with Region and will ensure that they begin to receive regular communication from us.

My hope is that this small but important step helps establish a line of communication between the Utah Region Outreach Subcommittee and the High Uintah Area. It may not be a substitute for an RCM, but it offers a way to bridge the gap and ensure the area has access to regional support if and when they need it.

Conclusion:

Overall, I was encouraged and inspired by the High Uintah Area's commitment to recovery and service. Their solutions are practical, grassroots, and deeply rooted in the needs of their community. I believe that with some ongoing support and improved communication, we can continue to help them thrive while respecting the unique circumstances they face.


