Utah Regional Delegate: Cody – Hey everyone sorry for my absence today I am currently on a plane headed to Alaska to go fishing..

There was a couple things that have happened and a couple things that I have missed due to life getting in the way. We did get involved on a motion as a co-maker of the motion to get full book length literature on tablets and a project plan on how to move forward with that.

“Motion intent and rational.

Motion: To direct the World Board to create a project plan for consideration at WSC 2029 to research and explore the opportunities and obstacles of providing book length pieces of literature to the incarcerated, on tablets, in addition to the IPs and audio version of the Fifth Edition Basic Text that already exist on inmate tablets.

Intent: To give the Conference and Fellowship the ability to meaningfully discuss the opportunities and obstacles of making book length pieces of literature available to the incarcerated on tablets.

Rationale: Narcotics Anonymous exists to carry a message of hope and freedom to every addict seeking recovery, including our members behind the walls. As correctional systems increasingly transition from physical books to secure digital tablets, many incarcerated addicts are being cut off from book length NA literature such as *Just for Today*, *It Works: How and Why* and *Living Clean*. Without action, this shift threatens to limit access to the foundation of our message for some of our most isolated members.

Approving this motion would allow the World Board to develop a project plan exploring practical, principled ways to make our Fellowship’s book length literature available through prison tablet systems. This plan would examine logistical, legal, financial, and Fellowship-related issues, ensuring that any approach upholds the principles of self-support and preserves the integrity of NA’s intellectual property, as outlined in the Fellowship Intellectual Property Trust (FIPT).

Many incarcerated members already face disparities in literature access, depending on facility policies and geography. Exploring digital options would help the Fellowship respond to these inequities while adapting to a changing environment. It also presents an opportunity to strengthen our trusted servant relationships with correctional institutions, ensuring that NA literature remains accessible to those with limited financial resources.

By supporting this motion, the World Service Conference would affirm our commitment to carrying the message to all addicts, regardless of circumstance, and empower the World Board to be proactive, bringing back informed options for Fellowship review and approval.”

Things that I was unable to attend was the rocky mountain zonal forum. I also had not put in a report I had run out of time to get one together we were driving down the road when I found out about it so were unable to get anything together for it. 




RCM Reports

Central: Eric S – Have sent \$60.05 donation for the last 2 months.

High Uintah: Not Present

Lakeside: Andi – Lakeside needs an RCM. We had 9 of 9 meetings present at our Area meeting. Danny attended our meeting, we have some positions open, H&I, Secretary, Diamond Detox and Elevations Youth Coordinator are all open. Having an event next Sunday – resentment water balloon fight on the 17th – Jimmy Johns and Water balloons.

Northern: Todd Report – Hasn't been a lot going on. NUACNA will be moved to the Ogden Hilton. Next Saturday the 16th after area will be the dodgeball tournament – Dodgeball saves lives. Northern's Freedom Fest is at Box Elder Campground the 22nd to 24th of August, and then Mens retreat is Sept 6-8.

Sasquatch: Kevin K – Sasquatch Area currently has 5 home groups, 2 in-person and 3 online; they're all current on the website. We take meetings into the Wasatch County jail on Monday nights. Our area has donated \$50 to the region for each of the June and August cycles, Venmo sent to Jess.

UWANA: Randy –

Greetings Utah Family!

Pride Festival was a tremendous success based on the volume of people that came by our booth. The final costs were \$844.04; which consisted of \$500 for the booth, \$67.88 for the required insurance, \$229 for literature and \$47.16 for candy. Drew K. has the receipts and will be issuing a refund check of \$356.95 to URNA. Many thanks to the entire Utah Region for the financial and physical support to participate in this event.

A biweekly schedule for checking the post office box has been initiated. UWASCNA has proposed Area guideline changes for the RCM team to add this to their responsibilities so the delayed response will be avoided in the future. All checks have been forwarded to Jess and a speaker CD was sent to Justin. There were five Step by Mail requests going back to 2024. I discussed this challenge with Lou and Todd. After some additional research, I discovered that three were still incarcerated and have initiated contact with two letters going to each. There are some additional challenges with Davis County jail not wanting to accept anything other than postcards and a couple of options to address this are being explored. More will be revealed...

Speaking of Guideline changes, UWASCANA Financial Ad Hoc Committee has drafted new Area Guidelines with a focus on updating financial procedures. These have gone back to the Home Groups for a vote next week. Our goals are to:

- 1) Provide NA Members and Home Groups with better visibility into how ASC funds are spent.
- 2) Provide a single point of accountability for managing approved ASC funds.
- 3) Provide money management tools to reduce time making financial decisions in ASC meetings.
- 4) Provide funds flow to URNA and NAWS that is clear and consistent.

One of the side benefits will be that Utah Region should start to see consistent quarterly donations from UWASCANA.

One item that got some attention at the last two ASC meetings was how UWASCANA should support URICNA and Campvention. The key takeaway is that UWASCANA will support these events as we have traditionally done through 2025. However, we do not want to use 7th Tradition funds to support any event outside of the Area starting in 2026. We hope that URICNA and Campvention will be self-supporting and feel these committees should ask for URNA funding if they are not as these are regional activities and URNA has accountability. UWASCANA will continue to support these two regional subcommittees with people to do whatever is necessary to have a successful event. And, we will continue to provide 7th Tradition funds flow to URNA to use as appropriate.

Brittini is asking for \$1417.44 – We will hold it again at Builders Studio. If it exceeds that amount we will float it – Brittini motioned, Todd 2nd PASSED.

Campvention Confirmations – Brittini Chair – qualified – PASSED//Leska Treasurer – qualified - PASSED

H&I and PR Balances Discussion – Working balance is \$3417.44, PR and H&I both have \$932.24 - \$5556.42 anticipated donation from Campvention. There has been discussion regarding AD Travel for April/May for WSC. We are also possibly talking about funding our RD travel as well rather than having that funded by NAWS.

Randy Motions: RD and ARD Team come back with proposed budget in October which will be 6 months in advance.

Motion - UWANA suggests we donate \$2000 to WSC from the working balance. – 2 in favor, 1 abstention, 1 opposed. - **PASSES**

Brittini said she will talk to Cody – it was about \$2800 in 2023, and we expect it will be \$3000-\$3500.

Randy asked what our expenses are for the Region. We have webhosting, storage (split by URICNA and Campvention), the costs are negligible. Our prudent reserve has \$500. Our norm over the last few years we have replenished URICNAs funds, we have hosted Pride and Recovery Days booths. We have spent money on books in the past but that seems to be a thing of the past. Our subcommittees are self supporting for the most part. We have in the past, usually sent most of our money to World.

Jess says we have about \$1000 a year in bills. Todd believes that we could easily do \$2500 for the donation rather than \$2000.
