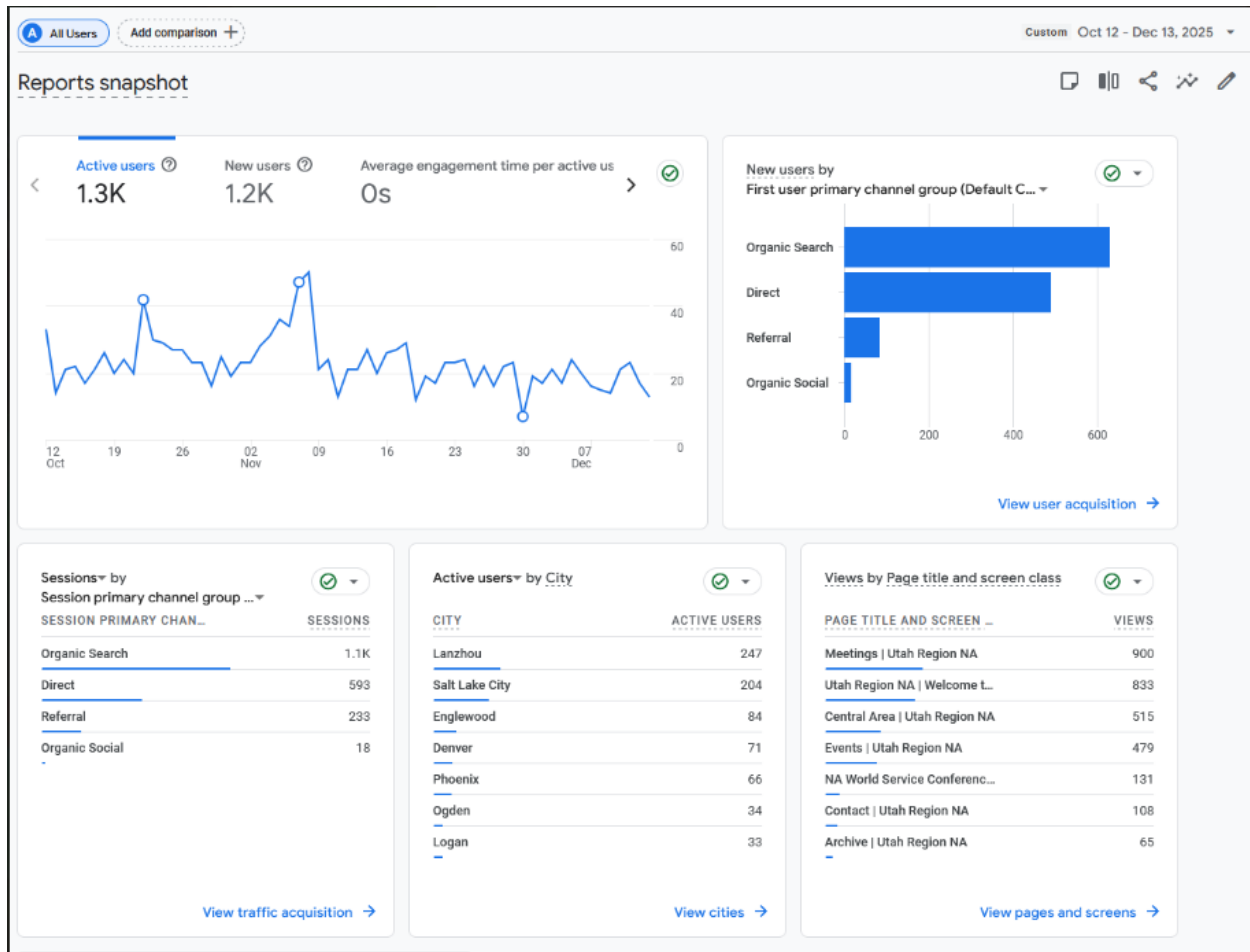
- Uploaded the October minutes to the **Archive** page.

Ad Hoc Committee – Utah Region of NA Archives and History: Lou B – No report

Ad Hoc Committee – Insurance: Randy –

I have been exploring liability insurance options for the Utah Regional Service Committee of Narcotics Anonymous (URSC). There is some guidance provided in the NA World Service Bulletin # 33; USA Liability Insurance Bulletin dated June 2007. https://na.org/wp-content/uploads/2024/08/Bulletin-33_Jun07-Insurance.pdf This provided some good context for the who, what, when, where, and how to acquire liability insurance. Here is some pertinent background information:

Why – NA trusted servants, groups, and committees have exposure to liability and liability insurance can provide vital protection for these individuals and for fellowship funds. A growing number of facilities require liability insurance.

What – Liability insurance provides protection against claims from third parties (hotels, churches, attendees, or innocent bystanders) for bodily injury, personal injury, or property loss or damage (accidents). Liability insurance also covers the cost to defend an asserted claim from a third party against the policyholder, whether or not the policyholder is later found not to have done anything wrong.

Who – Every NA group and committee who meets or holds functions should consider liability insurance coverage. Though each group or area service committee could purchase insurance coverage individually, most policies currently held within the fellowship are at the regional service committee level as this is the most economical approach.

How – A six step process...

- 1) Discuss needs – we agreed to explore options in our last meeting.
- 2) Gathering data – I am exploring options to cover:
 - a. All Home Group meetings, activities, and trusted servants
 - b. All Area Service Committee meetings, activities, and trusted servants
 - c. All Regional Service Committee meetings, activities, and trusted servants
 - d. This is proving challenging as many insurance companies want defined location, time, and officers of an incorporated entity
 - e. Another challenge is the types of activities as many insurance companies will not cover animals, campouts, or dances.
 - f. We need to confirm what insurance we have had in the past (including activities, conventions, etc.):
 - i. Who it was with (insurance carrier)?
 - ii. What was name of NA entity?
 - iii. Was there any claim history?
 - g. We also need to provide some financial information that is difficult for me to determine as we don't have a tax return or a financial roll-up of URICNA, Campvention, and the General Funds?
- 3) Name – I have been making applications under the full and legal name of "Utah Regional Service Committee of Narcotics Anonymous." All sub-groups would need to utilize that exact name (ie. URICNA subcommittee of Utah Regional Service Committee of Narcotics Anonymous) on all contracts, bank accounts, leases, tax returns, and articles of incorporation.
- 4) Insurance Agencies – I have been in touch with three so far. Two have turned us down. I am exploring who is being used by Region 51 and other NA Regions.
- 5) Determine adequate coverage – I am waiting to get options back from various insurance companies
- 6) Address and contact information – I will be the point of contact for quotes if that is agreeable with everyone here. We will need to determine who will execute the policy on behalf of URSC and who will be point of contact going forward to handle requests for proof of insurance and well as managing the insurance relationship?

Thank you for giving me the opportunity to explore insurance options for the Region.

Randy asked about the “excess funds”. We have a working balance and we need to assess what is needed for travel, see if womens retreat needs any funds, etc. There is a discussion to pass the money through the service structure and make the donation to world. **We would like to have a suggestion on the table that we will sent \$1500 from each of the buckets (PR and H&I) to world and this will be voted on next Region.** We want suggestions on how to fix this issue. There are possible guideline changes, not funding committees that don’t have a chair. New Ad-hoc committee formed for guidelines review – James will head this up.
